**Subject: First recorded warning for not maintaining sanctity of Board examinations held in May/June 2016.**

R/Sir,

Haryana State Board of Technical Education (HSBTE) is a statutory body established by an Act of legislature of the State of Haryana vide Act No. 19 of 2008. The said Act is to provide for establishment and constitution of the HSBTE for coordinated development of technical education in polytechnic institute in the State of Haryana and for matters concerned therewith or incidental thereto.

1. Under Section 27 (u) of the said Act HSBTE is empowered to grant affiliation, accreditation, autonomous status, equivalence and reviewing or revoking affiliation or accreditation, equivalence, or autonomous status as per regulations made under the provisions of this Act.
2. Under the said Act, HSBTE has framed Affiliation Bye-Laws and Examination Rules.
3. 567 Unfair Means Cases (UMC) were reported at Table Marking Centre (TMC) against the examination centre namely Janta College of Pharmacy, Butana, Sonapat which implies involvement of Janta College of Pharmacy, Butana, Sonapat in malpractice of large scale copying.
4. The Appellate Committee comprising of the experts was constituted by HSBTE under the provisions of Examination Rules to examine the said UMC cases.
5. The Appellate Committee on 04.08.2016 examined unfair means cases framed at TMC in respect of the examination centre Janta College of Pharmacy, Butana, Sonapat and decided that Show Cause Notice for disaffiliation be issued to the said examination centre under note (V) of Examination Rule 9.7.
6. Accordingly, Show Cause Notice for withdrawal of affiliation under note (V) of Examination Rule 9.7 was issued to your institute vide memo dated 19.09.2016.

In this regard, the reply of the institute that there was scarcity of the invigilators and poor performance of some of the invigilators is not satisfactory because vide office order no. 58/HSBTE/Exam dated 06/05/2016, six invigilators (1 from Govt. Polytechnic and 5 from Pvt. Polytechnics) were deputed in the Examination Centre at Janta College of Pharmacy, Butana and all staff members of Janta College of Pharmacy, Butana and Janta Polytechnic, Butana were at the disposal of the Supdt./Principal of the Examination Centre as no staff from these polytechnics were deputed in any other nearby polytechnic for invigilation duty.
8. Further as per clause 8 of "Instructions for Flying Squad" in Mandatory Instructions dated 27/04/2016, the Flying Squad was empowered to deal all the cases of shortage of invigilation staff at any centre and as such the Flying Squad could have been approached. Therefore, the reply of the institute regarding shortage/poor invigilation is not acceptable.
9. Furthermore, framing of 567 no. of UMC cases at this Centre only (at the level of TMC) out of 870 in whole of the State comprising about 140 Examination Centres and the fact that many candidates in subject ID 121925 committed same mistake by writing values of Na instead of values of Cl in part (n) of Q. No. 1 as per the report of UMC Committee, proves that the institution failed to provide favourable environment for conduct of examination in free and fair manner at the Centre in compliance of clause 2 for "Principal of institution loving Examination Centre," in Mandatory Instructions dated 27/04/2016.
10. As per the provisions contained in the Clause no. 6 of Chapter VI of Affiliation Bye-Laws of the Affiliation Bye-Laws of HSBTE pertaining to "Withdrawal of Affiliation":


*"If the Polytechnic/ Institution is found involved in any of the following malpractices or any other such practice, for each mal-practice a recorded warning shall be issued and **three recorded warnings shall lead to automatic disaffiliation of the polytechnic/institution from the immediate next academic session.***

- Charging of Capitation Fee
- Taking Donations
- Recruitment of unqualified Faculty/ Staff
- Under payment of Teachers
- Publication of misleading advertisement
- Giving admission on the basis of bogus documents or tampering of records.
- **Mass Copying/ Copying in Examinations**
- Non-attendance of students in the classes
- Sharing of facilities with other institutions.
- Retention of original Certificates of students

- Non- refund of tuition fee, in case of student withdrawing admission within stipulated time.
- Overcharging of hostel/ mess / transport charge
- Charging for Detailed Mark Certificate/ Diploma Certificate
- Charging for issuance of Roll No. for exams
- Any other un-authorized charge from the students

However, depending upon the gravity of the mal-practice, the disaffiliation process against the polytechnic/ institution shall be initiated directly, without issuing any warning".

11. Accordingly, exercising the provisions available in Clause no. 6 of Chapter VI of Affiliation Bye-Laws, **first recorded** warning is hereby issued to your polytechnic namely Janta College of Pharmacy, Butana, Sonapat on account of not maintaining sanctity of Board examinations held in May/June 2016.
