The Haryana State Board of Technical Education has been constituted by the Govt. of Haryana vide 19 Act of Legislation 2008 which has come into force on 6<sup>th</sup> May, 2008.

The chapter 2 provides for the establishment, constitutions, powers and duties of Governing council. As per clause 4(1) of the Act the Governing Council will be Apex body to control and monitor the matters pertaining to the Board. The constitution of Governing Council is as under:

6. Vice Chancellor, Guru Jambheshwar university of Science and Technology, Hisar : Member ex officio
7. Vice Chancellor, Deen Bandhu Chottu Ram university of Science and Technology, Murthal : Member ex officio
8. Chairman All India council of Technical Education or his nominee : Member ex officio
9. Engineer in Chief, Public Works Department (Building and Roads), Haryana : Member ex officio
10. Managing Director-Haryana Vidyut Parsaran Nigam. Ltd : Member ex officio
