**Subject:- Regarding Practical Examination and Rationalization of  
Sessional/Practical Awards – May 2016 Examination**


It is informed that:-

1. The external practical exams for all semesters will be conducted from 02.05.2016 to 06.05.2016 in all the Polytechnics/Institutions.
2. In all institutions the external practical exams will be conducted by the respective polytechnic(s), by deputing subject Experts from Universities/ Industries/ Engineering colleges under intimation to the Board.
3. External Practical marks must be awarded by conducting actual practical followed with viva-voce. The practical award lists and attendance sheets duly signed by the examiners must be retained for record by the institution(s).
4. The internal practical and sessional awards for all branches will be rationalized by the respective Rationalization Committee.
5. The Rationalization Committee shall visit the institutions preferably from 02.05.2016 to 06.05.2016.
6. The institutions will prepare all the records regarding sessional/ practical/ attendance/ teacher diary before the visit of the Rationalization Committee to their institute.
7. The institutes must provide all the data regarding practical/ sessional/ attendance/ any other related document to the Rationalization Committee. The Rationalization Committee will check the record of the sessional tests conducted during the semester.
8. The Principals of Govt./Govt. Society/Govt. Aided, may constitute a Rationalization Committee at their own level to verify the sessional/practical marks awarded before uploading the data on the HSBTE portal.
9. The internal practical and sessional awards after rationalization should be uploaded online correctly by the institute(s) upto 10.05.2016. The password has already been given to all institute(s) for online uploading the data.

10. The internal practical and sessional awards after rationalization should be uploaded online correctly by the institute(s) upto 10.05.2016. The password has already been given to all institute(s) for online uploading the data.

11. The **last date for uploading the internal/sessional/practical awards** online (on [www.hsbte.com](http://www.hsbte.com)) is **11.05.2016**.

**NOTE: The result of students whose sessional/ practical awards are not rationalized by the Rationalization Committee will not be declared by HSBTE.**


