

HARYANA STATE BOARD OF TECHNICAL EDUCATION (HSBTE) PANCHKULA

ORDER

Whereas, you are well aware that the Haryana State Board of Technical Education (HSBTE) is a statutory body established by an Act of legislature of the State of Haryana vide Act NO. 19 of 2008 (hereinafter referred to as the HSBTE Act) for coordinated development of technical education in polytechnic institutes in the State of Haryana for the matters concerned therewith or incidental thereto. Under Section 27 (u) of the aforesaid Act, the HSBTE is empowered to grant affiliation, accreditation, autonomous status, equivalence and reviewing, or revoking affiliation or accreditation, equivalence, or autonomous status as per regulations made under the provisions of this Act.

That as per the procedure prescribed in the affiliation bye-laws made under the HSBTE Act, the polytechnics/institutions are granted provisional affiliation for a period of one year subject to fulfillment of all the norms and conditions prescribed in the affiliation bye-laws.

As per Chapter III "CONDITIONS OF AFFILIATION" Point 2 of affiliation bye-laws of HSBTE:

*"*Faculty: New institutions granted letter of approval and the existing institutions granted approval for introduction of new course/s division/s program/s second shift and change in intake capacity, shall comply with appointment of teaching staff and Principal /Director as the case may be as per policy regarding minimum qualifications, pay scales etc., norms and other technical supporting staff & administrative staff as per the schedule prescribed in the Approval Process Handbook.*

In no circumstances unless the appointment of all teaching and other staff is in place, the institutions shall start the approved Technical Courses".

Further as per point no. 4 of affiliation bye-laws of HSBTE:

"Curriculum/ Learning Resources: The Polytechnic/ Institution shall carry out the teaching learning process strictly according to the curriculum and learning resources as prescribed by the Board from time to time".

Several complaints regarding non-engagement of classes and non-availability of teaching staff in IVT Polytechnic were received from the final year students of your institute narrating that there were no classes or staff and the college was closed for last one year.

Taking cognizance on the complaints the Board got conducted inspection of the institute on 11.04.2016 at 11:00 AM by an expert committee constituted by the Board.

The inspection committee reported that there was no teaching staff / Principal / Management Member were present in the institute on the day of inspection. All the rooms and labs were locked.

In reference to the inspection report, your institute was given a reasonable opportunity to clear its position and was requested to submit its reply by 05.05.2016 vide this office letter

dt. 26.04.2016 and a copy of the said letter was also endorsed to the Chairman of the Trust running the institute.

Meanwhile a grievance was also received in this office, through CM Portal, against your institute from the students of the institute narrating that the institute is closed for past one year even then the college is charging fee. No lectures and labs are being held for past one year. Also that the staff of the college is not uploading their PCA forms, even on the last date of updation of PCA forms i.e. 21.04.2016 for the oncoming May/June, 2016 Board examinations. The Chairman of the Trust running the institute was telephonically requested several times to resolve the problems being faced by the students and facilitate their PCA form updation.

Your institute was again requested vide this office letter dt. 17.05.2016 to clear its position and was requested to submit its reply by 25.05.2016 and a copy of the said letter was also endorsed to the Chairman of the Trust running the institute.

That besides above mentioned office communication(s), your institute was served with a show cause notice dt. 21.06.2016 to explain its position regarding non-fulfillment of the conditions of affiliation and another final show cause notice dt. 19.07.2016 to explain its position regarding non-fulfillment of the conditions of affiliation. However, your institute has failed to submit its reply or clarify its stand till date.

Opportunities of personal hearing were also granted vide the Board memo dt. 13.10.2016 and 02.11.2016. However, you failed to appear in front of the competent authority to clarify your position.

That as per the provisions of Chapter VI of the affiliation Bye-Laws and clause 23 of HSBTE Act, 2008; the HSBTE is empowered to disaffiliate/discontinue/withdraw affiliation in case the polytechnic/institute, at any time, is found guilty of committing, inter-alia, the act of non-fulfillment of the conditions of affiliation.

Therefore, in view of the above mentioned facts, it has been decided by the Board that that the affiliation of your institute namely Institute of Vertex Technologies, Radaur, YamunaNagar be discontinued from Haryana State Board of Technical Education, Panchkula w.e.f. the academic session 2016-17.

I, therefore, order accordingly.
