Subject: Mercy Chance to all the old students for HSBTE Examinations to be held in May/ June 2011.

The candidate shall be appearing only in the respective institute where he/she was bona- fide student.

The fee for the mercy chance shall be as per prevalent rules of HSBTE i.e. ` 1000/- per paper which shall be deposited by the candidate in the **Account No. 0087000111223535** of HSBTE in any CBS Branch of Punjab National Bank. The candidates should submit the PCA forms along with original fee receipt to their respective Principals preferably **upto 12.05.2011** The candidates shall be appearing in the new prevailing subject identities with current curriculum in the respective subject along with the regular candidates, as far as possible. All the Principals are requested to submit the applications received in original along with details of such candidates by intimating the subjects/ identities in which they are appearing, **upto 13th May, 2011**, and collect the required secrecy material from HSBTE.

You are requested to **provide/ give wide publicity about this mercy chance through the local media/ newspapers/ college notice board etc.** so that the concerned students may be informed timely for availing mercy chance given by the Board.
